

CHENNAI: BSP's Tamil Nadu president K Armstrong was hacked to death by a six-member gang near his house on Friday, police officers said.

The two-wheeler-borne gang attacked Armstrong, a former councillor of Chennai Corporation, near his house in Perambur at around 7.30pm when he was talking to an acquaintance, inflicting grievous injuries on him, and fled. He was rushed to a private hospital where he succumbed to injuries sustained on his head and neck.

The Chennai police have registered a case of murder, and formed a special team to track the suspects, the officer said, adding that the whole area has been placed under a security blanket.

Leaders across the political spectrum expressed shock over the incident.

"I strongly condemn the DMK government which has pushed law and order to such a bad level," AIADMK leader Edappadi Palaniswami.
