# HC relief for Shekhawat in Sanjivani scam, Union minister says truth can't be hidden


THE RAJASTHAN High Court Wednesday cleared Union Minister of Culture and Tourism Gajendra Singh Shekhawat in the Sanjivani Credit Co-operative Society scam stating that there is no case against Shekhawat.

A report submitted by the Additional Advocate General (AAG) said that no evidence was found against Shekhawat in the police investigation. A bench of Justice Arun Monga passed an order stating that on the basis of the detailed report submitted by the Special Operations Group, there is no case against Shekhawat.

Shekhawat had filed a petition to quash the FIR as well as the investigation against him. On September 17, Justice Monga had said, "It transpires that after completion of investigation as many as four

chargesheets have already been Advocate Aditya Vikram Singh said that the court has also made it clear that the SOG cannot conduct further investigation against Shekhawat without taking permission from the trial court. Along with the phone tapping case, the scam had become a bitter issue between former chief minister Ashok Gehlot and Shekhawat, with Gehlot repeatedly accusing Shekhawat of the scam and Shekhawat dragging Gehlot to the court for defamation.

Reacting to the developments, Shekhawat said on Wednesday that "truth cannot be hidden". Without naming Gehlot. Shekhawat said that "an

(Vaibhav's) defeat in the polls and the anger that the people of the state had given victory to the BJP. Today, the Rajasthan High Court has closed that case and has also ordered not to investigate further without the court's order. The court's order proves what kind of malicious attempt was made to implicate me."

# **AFTER 70 DAYS** Body of Kerala driver who went 'missing' in Shirur landslide found

SEVENTY DAYS after Keralabased lorry driver Arjun first went missing following a landslide in Ankola in Karnataka's Shirur, rescuers have finally pulled out his body from Gangavali river.

Arjun, a Kozhikode native who was driving a Benz lorrv with 40 tonnes of timber from Kerala's Kozhikode to Karnataka's Belgavi, had stopped his truck for tea when a massive landslide hit NH 66 and swept him away towards the river on July 16.

According to the disaster management officials, authorities fished out Arjun's truck around 2:30 pm on Wednesday in the spot previously indicated the river and recover the truck.

by a team of drone experts led by Maj Gen M. Indrabalan (retd). The body was found in the cabin of the truck.

"Subsequently, with continuous dredging, the State Disaster Response Force and the National Disaster Response Force recovered bones of cattle and parts of vehicles, including tyres and a steering wheel, from the river," a district administration official said. "Then. on Wednesday. Arjun's truck was found floating on the surface of the river, following which a dinghy was drawn closer to the spot to recover the mortal remains of Ariun from the vehicle's cabin." Wednesday's breakthrough came days after Uttara Kannada district administration deployed a floating craft dredger brought in from Goa to help clear silt in

The discovery of Arjun's body, which came on the back of mounting pressure from the Kerala government, brings the total number of deaths in the landslide to nine. An LPG tanker that had been swept away in the landslide was found in July.

Authorities are still looking for two more "missing" people.

Arjun's body is currently undergoing postmortem at a government hospital in Karwar. According to government procedure, the Uttara Kannada district administration will also conduct a DNA test to confirm Arjun's identity. For his family and friends, this marks the end of a long search. Abdul Munaf, whose Kozhikode-based company Sagar Koya Timbers owns the truck, said he "always knew" Arjun would be found in the truck's cabin.


