on Waqf Bill till Budget session

THE LOK Sabha Thursday passed a resolution to extend the tenure of the Joint Committee on the Waqf (Amendment) Bill till the last day of the Budget session

Joint Committee Chairman Jagdambika Pal moved a motion stating, "That this House do extend time for the presentation of the report of the Joint Committee on the Waqf (Amendment) Bill, 2024, up to the last day of the Budget Session, 2025." The Lok Sabha approved the motion with a voice vote.

The government had referred the Waqf (Amendment) Bill, tabled on August 8, to the

parliamentary committee to it following scrutinise Opposition's objections to the amendments. The panel's tenure was set to end on November 29.

Going by tradition, the Waqf (Amendment) Bill is expected to be taken up for consideration and passage only in the second half of the Budget session. The first week of the Budget session focuses on the economic survey report, President's address to the ioint session and presentation of the Union budget and discussion

Pal sought an extension of the tenure of the panel after its Opposition members staged a walkout from the meeting of the committee on Wednesday. The Opposition members had alleged that procedures and rules were not being followed and the panel chairman was planning to submit the report on November 29 despite their request to Lok Sabha Speaker Om Birla to extend the tenure of the commit-

Gaurav Gogoi of the Congress, A Raja of the DMK. Sanjay Singh of the AAP, and Kalyan Banerjee of the TMC had alleged that Pal was keen to wrap up proceedings by the November 29 deadline without completing due process. Opposition members of the

panel met Speaker Om Birla on Monday and requested a reasonable extension of the tenure of the panel. In a letter given to the Speaker, the Opposition members said that the committee had its first meeting on August 22 and had held only 25 sittings, including those where presentations were made by "various irrelevant" organisations and individuals.The Joint Committee comprises 21 members from the Lok Sabha and 10 from the Rajya Sabha. It has 13 Opposition members – nine from the Lower House and four from the Upper House.

Opp parties demand discussion over Adani row, violence in Manipur, Sambhal

DISRUPTIONS CONTINUED to stall Parliament proceedings for the third straight day on Thursday, with both Houses getting adjourned for the day soon after reconvening at 12 noon amid protests by Opposition parties over the Adani issue and violence in Manipur and Sambhal.

While adjournment motion notices by Members of Opposition parties on various subjects were rejected by Speaker Om Birla in the Lok Sabha, Rajya Sabha chairman Jagdeep Dhankhar rejected all 16 notices from various Opposition parties under Rule 267.

The Lok Sabha proceedings started at 11 am with Congress leader Priyanka Gandhi Vadra taking oath as Wayanad MP, followed by the party's Ravindra Vasantrao Chavan taking oath as MP from Nanded.

The Question Hour that began soon after was interrupted by protesting Opposition MPs even as the Speaker repeatedly asked them to return to their seats.

"I assure you that you will get adequate time and opportunity for issues you want to discuss. But you are trying to stall the House in a planned manner," Birla said. He said the members had been elected by people with great hope

and they should raise the issues concerning their voters. "...Rules and procedures have to be followed to discuss things that have nothing to do with the country," he said on the Opposition's demand for a discussion on the allegations against the Adani Group in the US.

As disruptions continued, Birla adjourned the House till noon. When the House met

again, it was announced by TDP MP K P Tenneti, who was in the Chair, that the Speaker had disallowed all adjournment motion notices on different subjects. Interruptions continued as papers were laid on the table of the House. In the meanwhile, a motion to extend the duration of the IPC examining the Wanf (Amendment) Bill up to the last day of Budget Session 2025 was adopted by the House.

the Upper House. "As of October 31, there are 5,182 vacant teaching posts in central universities. Through special recruitment drives, more than 7,650 teaching positions have been filled in the central

universities," the minister said. "Occurring of vacancies and filling thereof is a continuous process. The vacancies arise due to retirement, resignation and additional requirements on account of enhanced students' strength; the onus of filling up posts lies on central universities,' he added.

Majumdar noted that the ministry and the University Grants Commission (UGC) regularly monitored the institutions and that the central universities had been directed to fill the vacancies in regular mode. PTI
