They pointed out that on July 29, when BJP MPs had submitted a similar notice to discuss the deaths in an IAS coaching centre in Delhi, they were allowed a Short Duration Discussion. Opposition MPs said they would be left with no option but to protest if the House is not run according to the Rules and Precedents.

After Dhankhar left the House, Deputy Chairman Harivansh chaired the Zero Hour proceedings.

Returning to chair the Question Hour, Dhankhar said he found the scenes in the House before he left "unprecedented, indigestible". "It is our bounden duty to take tough decisions," he said, adding that he had "left to introspect" and informed that he has called a meeting of floor leaders to discuss the matter.
