Sub: NOTICE UNDER SECTION 13 (2) OF THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002 ("SARFAESI ACT, 2002") READ WITH SECURITY INTEREST (ENFORCEMENT) RULES, 2002 AS AMENDED FROM TIME TO TIME.

Sir,

1. We, PNB Housing Finance Limited (PNBHFL) is a Company incorporated under the Companies Act, 1956, and registered with National Housing Bank (NHB) in terms of Section 29A of the National Housing Bank Act, 1987 and having its Registered office at 9th Floor, Antriksh Bhawan, 22, K.G. Marg, New Delhi-110001, and is a notified Company under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as the "SARFAESI Act") by Ministry of Finance on 10.11.2003, and is engaged inter-alia in the business of rendering finance/loan facilities, to the intending borrowers, primarily against the security of "immoveable property".

2. You the above-named Addressee No. 1 is the Borrower Company, duly incorporated under the Companies Act, 1956 being represented by your respective Directors/Authorised Signatory along with the Security Provider i.e. Addressee No. 2 have approached PNBHFL, requesting the grant of Construction Finance/Corporate Term Loan Facility for the sum of Rs.300,00,00,000/- (Rupees Three Hundred Crores Only) (hereinafter referred **Loan Facility 1**), Rs.90,00,00,000/- (Indian Rupees Ninety Crore Only) (hereinafter referred **Loan Facility 2**) and Rs.695,00,00,000/- (Indian Rupees Six Hundred and Ninety Five Crore) (hereinafter referred **Loan Facility 3**) (collectively referred as **Loan Facilities**) wherein Addressee No. 3 stood as a Guarantor. (Hereinafter all the above-named Addresses be collectively referred as "**Borrowers**")
3. Pursuant to your specific representations inter-alia with respect to adherence of the terms of repayment of the said Loan Facilities, PNBHFL has sanctioned Construction Finance Facilities across various timelines for the sum of Rs. 300,00,00,000/- (Rupees Three Hundred Crores Only) vide Sanction Letter dated 29.12.2016 as Loan Facility 1, Rs. Rs.90,00,00,000/- (Indian Rupees Ninety Crore Only) vide Sanction letter dated 22.01.2018 as Loan Facility 2 and Rs.695,00,00,000/- (Indian Rupees Six Hundred and Ninety-Five Crore) vide Sanction letter dated 31.08.2018 in favour of you, the above named borrowers vide Loan Account No. WFN/CCF/0616/297395, WFN/CCF/0118/482644 and WFH/CCF/0918/575112 respectively thereto which respective Loan Agreements dated 09.09.2016, 05.02.2018 &10.09.2018 ("**Loan Agreements**") against the said Construction Finance Loan/Corporate Term Loan Facility were executed along with certain other Loan related documents to create equitable mortgage by way of deposit of original title deeds in respect of immoveable properties in favour of PNBHFL against the said Construction Finance Loan/Facility.
4. Subsequent to the execution of Construction Finance Loan/Corporate Term Loan related documents, the above said Loan Facility No.1 was disbursed in two tranches for Rs. 212,80,00,000/- (Indian Rupees Two Hundred Twelve Crores and Eighty Lakh Only)(Loan A) and Rs. 87,20,00,000/- (Indian Rupees Eighty Seven Crore Twenty Lakhs Only)(Loan B) respectively. Thereafter on 07.02.2018 Loan Facility No.2 for Rs.90,00,00,000/- (Indian Rupees Ninety Crore Only) was disbursed. Thereafter, the Loan Facility No.3 was disbursed in various tranches for Rs. 230,00,00,000/- (Indian Rupees Two Hundred and Thirty Crore Only) from September 2018 - December 2019 and no disbursement has been made for other loan accounts in respect of this facility. However, as per the terms and conditions of the Sanction Letter issued for Loan Facility no.3 after this disbursement, the Loan A amounting to Rs. 212,80,00,000/- (Rupees Two Hundred Twelve Crores and Eighty Lakh Only) stands closed.
5. We inform you that the above mentioned Facilities were inter-alia are secured by creating security interest on the following Immoveable Properties/Receivables wherein the charge has been duly registered with the ROC in favour of PNBHFL:

"Equitable mortgage (by deposit of title deeds) on all that piece and parcel of land admeasuring 77,878 square meters(19.24 acres) of project "Aarohan Residences" situated at village Wazirabad and Haiderpur Viran, Tehsil and District Gurgaon, Haryana along with all the present and future construction thereon including all the rights , title, interest over the said land and the construction but does not include land area of approximately 12873 square meters (3.181 acres) on survey no.1692 and structure thereon of a commercial tower,situated at Golf Course Road,Sector 53,Gurgaon excluding the following units-"





12. Under the circumstances, PNBHFL is taking recourse to the express provisions as contemplated in Section 13(2) of the SARFAESI Act, 2002, hereby call upon you all the addressees, to repay the aforesaid amount of Rs.377,98,09,343.28/- (Rupees Three Hundred Seventy Seven Crore Ninety Eight Lakh Nine Thousand Three Hundred Forty Three and Twenty Eight Paise Only) along with future interest computable till the date of payment in full, within **60 (Sixty) days** from the date of the notice, failing which we shall be entitled to exercise any and/or all of the rights, available to a secured creditor and as more specifically stipulated in Sub-Section (4) of Section 13 of the SARFAESI Act; which will include one or more of the following measures to recover PNBHFL's secured debt, namely: -
- take possession of the secured assets of the borrower including the right to transfer by way of lease, assignment or sale for realizing the secured assets;
 - take over the management of the secured assets of the borrower including the right to transfer by way of lease, assignment or sale and realize the secured asset;
 - appoint any person (hereafter referred to as the manager), to manage the secured assets the possession of which has been taken over by the secured creditor;
 - require at any time by notice in writing, any person who has acquired any of the secured assets from the borrower and from whom any money is due or may become due to the borrower, to pay the secured creditor, so much of the money as is sufficient to pay the secured debt.

Details of the Secured Assets in respect of which PNBHFL shall be constrained to enforce its rights, in the event of nonpayment of the aforesaid amount, within the aforesaid period is more specifically enumerated in **Schedule-II**, appearing hereunder.

You are further requested to note that as per Section 13(13) of SARFAESI Act, you are restrained/prohibited from disposing of or dealing with the above-Secured Assets or transferring by way of sale, lease or otherwise (other than in the ordinary course of business) any of the above Secured Assets, without prior written consent of PNBHFL. We may add that non-compliance with the above provision contained in Section 13(13) of SARFAESI Act, is an offence punishable under section 29 of the said Act.

Please note that your attention is invited to provisions of Sub-Section (8) of Section 13 of the SARFAESI Act, 2002 whereunder you can tender/pay the entire amount of outstanding dues together with all costs, charges and expenses incurred by our Company only till the date of publication of the notice for sale of the Secured Asset(s) by public auction, by inviting quotations, tender from public or by private treaty. Please also note that if the entire amount of outstanding dues together with the costs, charges and expenses incurred by our Company is not tendered before publication of notice for sale of the Secured Asset(s) by public auction, by inviting quotations, tender from public or by private treaty, you may not be entitled to redeem the Secured Asset(s) thereafter.
15. Please also note that this notice is sent to you without prejudice to the other rights and remedies available to PNBHFL including initiation of the appropriate legal proceedings before the appropriate courts and/or tribunal for recovery of the above





said outstanding amount. This notice is also without prejudice to PNBHFL's right for undertaking the prosecution of any other complaint filed by PNBHFL.

16. Any correspondence in this regard may be addressed to the Authorised Officer at the above-mentioned Registered Office at New Delhi.

You are therefore called upon to comply with the demand under this notice and to avoid further action under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002, read with Security Interest (Enforcement) Rules, 2002 which shall be at your costs and consequences, OF WHICH PLEASE TAKE NOTICE.
