 - In view of the fact that the Company has utilized a sum of ₹ 18,530.23 Lakhs (Rupees Eighteen Thousand Five Hundred Thirty Lakhs and Twenty Three Thousand Only) i.e. 99.62% of Maximum Buyback Size (excluding Transaction Costs) with a balance of ₹ 69.77 Lakhs (Rupees Sixty Nine Lakhs Seventy Seven Thousand Only), the Company has decided to close the Buyback on Thursday, July 6, 2023. Intimation for closure of the Buyback was sent to the Stock Exchanges on Wednesday, July 5, 2023.
 - The total number of Equity Shares bought back under the Buyback is 46,50,000 (Forty Six Lakhs Fifty Thousand Only).
- Details of the Buyback**
 - The Company bought back a total of 46,50,000 (Forty Six Lakhs Fifty Thousand Only) (1.05% of the pre-buyback paid-up equity share capital of the Company), and the total amount invested is ₹ 18,530.23 Lakhs (Rupees Eighteen Thousand Five Hundred Thirty Lakhs and Twenty Three Thousand Only) (excluding Transaction Costs), which represents 99.62% of the Maximum Buyback Size. The price at which the Equity Shares were bought back was dependent on the price quoted on BSE Limited and National Stock Exchange of India Limited, together referred to as "Stock Exchanges". The highest price at which the Equity Shares were bought back was ₹ 439.00 per Equity Share while the lowest price was ₹ 362.41 per Equity Share. The Equity Shares were bought back at an average price of ₹ 398.50 per Equity Share. These prices are based on contract notes issued by the Company's broker (IIFL Securities Limited) and exclude Transaction Costs. 



दिल्ली में एक दिन में पिछले 40 वर्षों में सबसे अधिक वर्षा

दक्षिण-पश्चिम मानसून ने अपना प्रकोप दिखाना शुरू कर दिया है। पश्चिमोत्तर भारत के अधिकांश हिस्सों में भारी बारिश के कारण भूस्खलन एवं अन्य संबंधित घटनाओं में करीब 15 लोगों की मौत हो गई। दिल्ली में यमुना सहित इस क्षेत्र की अधिकतर नदियां उफान पर हैं।

मूसलाधार बारिश के कारण तमाम शहरों और कस्बों की न केवल सड़कें बल्कि रिहायशी क्षेत्र घुटनों तक पानी में डूब गए और पूरी व्यवस्था चरमरा गई। अचानक आई बाढ़ से पहाड़ी इलाकों में सड़कें बह गईं जिससे लोग काफी परेशान हो गए हैं। अधिकारियों ने पर्यटकों को सलाह दी है कि वे मौसम में सुधार होने के बाद ही अपनी यात्रा पर निकलें।

रेलवे सेवाएं भी प्रभावित हुई हैं। उत्तर रेलवे ने कहा कि उसने लगभग 17 ट्रेनों को रद्द कर दिया है और लगभग 12 अन्य का मार्ग बदल दिया है। जलभराव के कारण चार जगहों पर यातायात निलंबित कर दिया गया है। जम्मू-कश्मीर, लद्दाख और हिमाचल प्रदेश के कुछ इलाकों में भारी बारिश की चेतावनी जारी की गई है। दिल्ली में 1982 के बाद जुलाई में दिन भर की सबसे अधिक बारिश दर्ज की गई। अधिकारियों ने यमुना के बढ़ते जल स्तर के मद्देनजर चेतावनी जारी की है।

मौसम विभाग के अनुसार, रविवार सुबह साढ़े आठ बजे को समाप्त हुए 24 घंटों के दौरान दिल्ली में 153 मिमी बारिश हुई। जबकि इस दौरान चंडीगढ़ में 322.2 मिमी और हरियाणा के अंबाला में 224.1 मिमी बारिश हुई।

हिमाचल प्रदेश में भूस्खलन की तीन घटनाओं में पांच लोगों की मौत हो गई। राज्य के सात जिलों में अत्यधिक बारिश का रेड अलर्ट जारी किया गया है।

पर्याप्त बारिश ने दक्षिण-पश्चिम मानसून की सारी कमी की भरपाई सुनिश्चित कर दी है। महज आठ दिनों के भीतर बारिश में 10 फीसदी कमी अब 2 फीसदी अधिक हो गई है। इस साल मानसून सीजन में 9 जुलाई, 2023 तक कुल बारिश 243.2 मिमी तक पहुंच चुकी है जो सामान्य 239.1 मिमी से 2 फीसदी अधिक है। दिल्ली में, 8 जुलाई को सुबह साढ़े आठ बजे से 9

जुलाई को सुबह साढ़े आठ बजे के बीच 153 मिमी बारिश दर्ज की गई। जबकि 9 जुलाई को सुबह साढ़े आठ बजे से उसी दिन शाम डेढ़ बजे तक 106 मिमी बारिश हुई।

इससे पहले जुलाई में एक दिन की सबसे अधिक बारिश 25 जुलाई 1982 को दर्ज की गई थी जब 24 घंटों के भीतर शहर में लगभग 169.9 मिमी बारिश हुई थी। रविवार सुबह तक हुई बारिश जुलाई महीने में 1958 के बाद राजधानी में दर्ज की गई तीसरी सबसे अधिक बारिश है।

मौसम विभाग ने एक बयान में कहा, 'पश्चिमी विक्षोभ और मानसूनी हवाओं के बीच संपर्क के कारण पश्चिमोत्तर भारत में जबरदस्त बारिश हो रही है। इसमें दिल्ली भी शामिल है जहां इस सीजन की पहली बहुत अधिक बारिश हुई है।'

दिल्ली प्रशासन ने एहतियात के तौर पर सोमवार को सभी स्कूलों को बंद करने का आदेश दिया है। केंद्रीय गृह मंत्री अमित शाह ने दिल्ली के उपराज्यपाल विनय कुमार सक्सेना से बात की और स्थिति का जायजा लिया।

सोमवार को भी अच्छी बारिश होने का अनुमान है। पड़ोसी राज्य हरियाणा द्वारा हथनीकुंड बैराज से एक लाख क्यूसेक से अधिक पानी छोड़े जाने के बाद दिल्ली सरकार ने यमुना में बाढ़ की चेतावनी जारी की है।

गुरुग्राम भी पिछले कुछ दिनों से मानसून के प्रकोप का सामना कर रहा है। वहां की लगभग सभी प्रमुख सड़कें घुटनों तक पानी में डूबी हुई हैं। जिला प्रशासन ने शहर के सभी कॉर्पोरेट्स और कंपनियों को अपने कर्मचारियों के लिए सोमवार को घर से काम सुनिश्चित करने का निर्देश दिया है।

पश्चिमोत्तर भारत में 9 जुलाई को सामान्य से 383 फीसदी अधिक बारिश हुई। पंजाब में 24 घंटे में सामान्य से 115.1 फीसदी अधिक, हिमाचल प्रदेश में सामान्य से 119.3 फीसदी अधिक और जम्मू-कश्मीर एवं लद्दाख में सामान्य से 90.1 फीसदी अधिक बारिश दर्ज की गई। जहां तक अन्य राज्यों का सवाल है तो हरियाणा, चंडीगढ़ और दिल्ली में 24 घंटों में 788 फीसदी अधिक बारिश हुई। गाजियाबाद और नोएडा सहित पश्चिमी उत्तर प्रदेश में 24 घंटों में 238 फीसदी अधिक बारिश हुई।

दिल्ली हवाई अड्डे पर 20 उड़ानें रद्द, 120 में देरी

उत्तर भारत में भारी बारिश के बीच रविवार को दिल्ली हवाई अड्डे पर करीब 20 उड़ानें रद्द कर दी गईं और 120 की सेवाओं में देरी हुई। विमानन उद्योग के सूत्रों ने यह जानकारी दी। उन्होंने बताया कि इन 140 उड़ानों में प्रस्थान और आगमन दोनों उड़ानें शामिल हैं।

सूत्रों ने बताया कि रविवार को रद्द की गई 20 उड़ानों में राष्ट्रीय राजधानी और धर्मशाला, शिमला एवं लेह जैसे मौसम प्रभावित शहरों के बीच संचालित होने वाली उड़ानें हैं।

रविवार को दिल्ली-धर्मशाला और दिल्ली-लेह जैसे मार्गों पर स्पाइसजेट की करीब 12 उड़ानें रद्द कर दी गईं। सूत्रों ने बताया कि भारी बारिश के कारण विस्तार में रविवार को अपनी दिल्ली-लेह और लेह-दिल्ली उड़ान रद्द कर दी। दिल्ली हवाई अड्डे से आने-जाने



सबसे अधिक असर इंडिगो की उड़ान पर

वाली लगभग 40 फीसदी उड़ानें इंडिगो की हैं। इसलिए रविवार को खराब मौसम के कारण उसका परिचालन सबसे अधिक प्रभावित हुआ। सूत्रों ने बताया कि रविवार को दिल्ली हवाई अड्डे पर इंडिगो की करीब 55 उड़ानों में देरी हुई। सूत्रों ने बताया कि रविवार को एयर इंडिया की करीब 27 उड़ानों में भी देरी हुई। एयर इंडिया, इंडिगो, विस्तारा और स्पाइसजेट ने इस मुद्दे पर पूछे जाने पर कोई जवाब नहीं दिया।

कम बारिश से पहले बढ़ती थी महंगाई पर अब नहीं

पिछले कई दशकों के दौरान अपर्याप्त बारिश से खाने-पीने की वस्तुओं की महंगाई दर की तुलना में हाल के वर्षों में इसकी चोट कम रही है। डीएसपी एंसेट मैनेजर्स जुलाई, 2023 की नेत्र रिपोर्ट के अनुसार 1960 और 1970 के दशकों के दौरान जब भीषण सूखा पड़ा था तब खाद्य महंगाई दो अंकों में पहुंच गई थी। मगर शताब्दी के बाद के वर्षों में कम बारिश के दौरान महंगाई मोटे तौर पर एक अंक तक ही सीमित रही।

आधिकारिक अनुमानों के अनुसार वर्षा दीर्घ अवधि के औसत का 96 प्रतिशत तक रह सकती है। मौसम का अनुमान लगाने वाली निजी संस्था स्काईमैट के अनुसार वर्षा दीर्घ अवधि के औसत का 94 प्रतिशत के स्तर पर रह सकती है। बारिश कम रहने से पूर्व के दशकों में खाद्य वस्तुओं में तेजी दर्ज हुई थी। 1965-66 और 1966-67 के दौरान महंगाई दर बढ़कर 10-14 प्रतिशत तक हो गई थी। वर्ष 2015-16 में यह 6.2 प्रतिशत और 2014-15 में 4.3 प्रतिशत बढ़ गई था। 2009-10 में इसमें 18.8 प्रतिशत की वृद्धि हुई थी। मगर यह 2004-05 और 2002-03 के दौरान 5 प्रतिशत के नीचे रही थी। रिपोर्ट में कहा गया है कि पूर्व के दशकों की तुलना में महंगाई से निपटने के तौर-तरीके बदलने से अब असर कम रह सकता है।

रिपोर्ट में यह भी कहा गया कि वैश्विक स्तर पर खाद्य वस्तुओं की कीमतों में तेजी, भारत में आर्थिक हालात से जुड़े मसलों और कमजोर मुद्रा सहित अन्य कारणों से भी पहले महंगाई दर में बड़ा इजाफा हुआ था। रिपोर्ट में कहा गया है कि अब बेहतर ढांचा उपलब्ध होने से अल-नीनो के प्रतिफल प्रभावों के बावजूद महंगाई से बेहतर तरीके से निपटा जा सकता था। इसमें कहा गया है, अल-नीनो के कारण मानसून कमजोर रहने की स्थिति में महंगाई दर में बढ़ोतरी और आर्थिक विकास दर के लिए जोखिम कम से कम रहेंगे। मगर अल-नीनो का प्रभाव अधिक हुआ तो विकास दर नरम जरूर पड़ सकती है।

बिज़नेस स्टैंडर्ड ने पिछले कुछ दशकों में मानसून की रफ्तार से जुड़े आंकड़ों का अध्ययन किया है। इसके अनुसार हाल के वर्षों में 2017 में मानसून को देश के सभी हिस्सों में पहुंचने में लगभग 50 दिनों का समय लग गया था। इसकी तुलना में 2013 में मानसूनी हवाएं केवल 15 दिनों में ही देश के हरेक हिस्से में पहुंच गई थीं। इस साल 8 जून को मानसून ने केरल में दस्तक दी थी। 2 जुलाई तक यह पूरे देश में पहुंच गया था। इस तरह, इस केरल से लेकर देश के दूसरे सभी हिस्सों में पहुंचने में 24 दिनों का समय लगा। इससे पहले 2015 में मानसून ने केवल 21 दिनों में पूरे देश में दस्तक दे दी थी।
