Summary of the Proceedings of the 30th Annual General Meeting of the Company

The 30th Annual General Meeting (AGM) of the Members of the Company was held on Friday, July 27, 2018 at 3.00 p.m. at the "The Stein Auditorium" Habitat World, at India Habitat Centre, Lodhi Road, New Delhi-110003. The meeting was attended by 186 Members in person or by proxy. The requisite quorum being present, Mr. Sanjay Jain, Company Secretary and Head Compliance, called the meeting to order and welcomed the Members to the meeting.

Quorum for the AGM:



The Company Secretary confirmed the presence of requisite quorum in terms of Section 103 of Companies Act, 2013.

Proceedings of the meeting are given hereunder:

- 1. The Company Secretary extended a warm welcome to the Members, Directors and others present in the meeting. Thereafter, he introduced each member of the Board to the shareholders and others present.
- 2. The Chairman and the Managing Director delivered their speeches. The Chairman then advised the Company Secretary to start the proceedings of the meeting.
- 3. The Company Secretary informed that Statutory Registers, Proxy registers, attendance, annual reports and other relevant documents were made available for inspection by the Members.
- 4. The Company Secretary informed that the Notice convening the AGM and Annual Report for the Financial Year 2017-18 were sent to all the members and others entitled thereto through e-mail and registered post on July 3, 2018
- 5. The Company Secretary then informed the members that in terms of the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, The Companies Act, 2013 and the rules made thereunder, the Company had provided remote e-voting facility to its Members to cast votes electronically, on all the resolutions set out in the Notice and the same commenced at 9.00 a.m. on Monday, July 23, 2018 and ended at 5.00 p.m. on Thursday, July 26, 2018.

He further informed that the Company had engaged the services of Central Depository Services Limited (CDSL) to provide remote e-voting facility.

He further informed that the facility for voting through ballot paper is also available at the meeting for members who had not cast their vote through remote e-voting.

6. Thereafter, he invited the members for their queries. The following agenda items were taken up and the Company Secretary briefed their implications:

A. Ordinary Business

- 1. To receive, consider and adopt Standalone and Consolidated Audited Financial Statements of the Company for the financial year ended March 31, 2018 and the Reports of the Board of Directors' and Auditors' thereon
- 2. To declare dividend on Equity Shares at the rate of Rs. 9/- per share for the financial year 2017-18.

- 3. To appoint Mr. Sunil Mehta (DIN: 07430460) as non-executive director, who retires by rotation and, being eligible, offers himself for re-appointment.
- 4. To appoint the Statutory Auditors to hold the office from the conclusion of 30th Annual General Meeting until the conclusion of the 35th Annual General Meeting of the Company and to authorise the Board of Directors of the Company to fix their remuneration.

B. Special Business

- 5. The item was withdrawn: Appointment of Mr. Jayant Dang as Independent Director.
- 6. To borrow money not exceeding Rs. 90,000 crore at any point of time and to issue non-convertible debentures of face value aggregating up to Rs. 45,000 crores.
- 7. Increase in limits for investment in the equity share capital of the Company by Foreign Portfolio Investors (FPI) from 24% to 74%.
- 8. Approval of PNB Housing Employees Stock Option Scheme II, 2018.

The members were informed that the Board of Directors had appointed Mr. Sanjay Grover, Practising Company Secretary as Scrutinizer for the purpose of scrutinizing the remote e-voting and ballot process in a fair and transparent manner.

The members were informed that the results of e-voting will be declared within 48 hours from the conclusion of the meeting and shall be submitted to the Stock Exchanges and also unloaded on the website of the Company (www.pnbhousing.com) and Central Depository Services Limited (www.evotingindia.com)

The Chairman ordered the poll requesting all members to cast their votes using polling papers handed over to them. The Chairman thanked the shareholders for attending the meeting.

The Company Secretary proposed a vote of thanks to the Chair and the meeting ended.
