The Trustees shall protect the interest of the Bondholders in the event of default by the Company in regard to timely payment of interest and repayment of principal and shall take necessary action at the cost of the Company. No Bondholder shall be entitled to proceed directly against the Company unless the Trustees, having become so bound to proceed, fail to do so.

In pursuance of the extant provisions, it shall be the duty of the Trustee to:

- (a) satisfy himself that the Private Placement Offer Letter does not contain any matter which
  is inconsistent with the terms of the issue of Bonds or with the Debenture Trust Deed
  and/or other document(s);
